RELEASE AND INDEMNIFICATION AGREEMENT**

I, INDIVIDUALLY AND AS THE VESSEL'S MASTER (IF INDEED, I AM THE VESSEL'S MASTER), MY BOAT'S MASTER (IF OTHER THAN BOAT'S OWNER OR OPERATOR), MY TEAM, THE BOAT'S CREW, AND GUESTS ABOARD AGREE AND UNDERSTAND THE SOUTHERN KINGFISH ASSOCIATION, THEIR DIRECTORS, OFFICERS, EMPLOYEES, AGENTS AND AND/OR SPONSORS (HEREINAFTER REFERRED TO AS "SKA") SHALL NOT BE LIABLE UNDER ANY CIRCUMSTANCES FOR ANY INJURIES OR DAMAGES TO PERSON(S), BE THEY PHYSICAL INJURIES OR OTHERWISE, OR PROPERTY OF ARISING OUT OF, RESULTING FROM, OR IN ANY WAY CONNECTED WITH my/our crew's participation in any tournament whether caused by or contributed to by any negligent act or negligent omission of SKA or by any other reason or cause whatsoever. In consideration or the acceptance of me and my team and my crew entry and for other good and valuable consideration received, we hereby remise release and forever discharge SKA and its respective heirs, executors, administrators, legal representatives, successors, assigns, parent organization/firm, or any firm/organization that SKA is part of or a division of, its/their directors, officers, employees and/or agents of, from all claims, suits, obligations, liabilities, losses, damages, cost of expenses which are master, crew, owner(s), operator(s), team or guest aboard of theirs, executors, administrator, legal representatives, successors and or assigns may have against SKA arising of, resulting from, or any way connected, with my/our participation in any tournament. We understand this release includes my claims based upon any negligent act or negligent omission of SKA. To the fullest extent permitted by law, I (individually and as vessel's master), the boat's master (if other than the boats owner or operator), my team and the vessel's crew and guest aboard hereby agree to indemnify, to defend with counsel acceptable to SKA and to hold SKA and its heirs, executors, administrators, legal representatives, successors, assigns, parent firm/organization or any firm/organization that SKA is a part of or a division of, its/their directors, officers, employees, and agents harmless from and against any and all claims, suits, obligations, liabilities, losses, damages, cost of expenses and including but not limited to reasonable attorney fees suffered by SKA or by any other person or persons whatsoever (including anyone for whose acts SKA may be liable), regardless of whether it is caused by—or by a party indemnify held harmless hereunder, arising out of, resulting from, or any way connected my/our participation in any tournament. All boats, owners, operators, masters, crews, guest and anglers will operate their vessels and/or fish at their own discretion and solely at their own risk. This agreement shall take effect as an instrument under seal and be binding upon an insure to the benefit of me (individually and as a master of a vessel, if indeed I am the master of the boat), my boat's master (if different than the owner or operator), my team, the boat crews and guest aboard, as well as the heirs, executors, administrators, successors, assigns of each.
